### Waiver and Release of Liability Agreement

2. <u>Assumption of Risk</u>: I understand and acknowledge that engaging in Do-it-Yourself (DIY) home repair and automotive maintenance, including the use of power tools, presents a significant risk of injury. While the tools available to members through the Do-it-Yourself (DIY) ("Club Tools") are all commercially available, are designed with user safety in mind, and are approved by the appropriate industry, state and federal government organizations, the risk of serious injury still exists. Therefore, I accept and assume full responsibility for any risk of personal injury, accident, illness, death, or lost, stolen, or damaged property, and accept and assume the risk of any medical or physical condition I may have.

3. <u>Waiver of Rights, Release from Liability, and Indemnification</u>: I VOLUNTARILY RELEASE, FOREVER DISCHARGE, AND AGREE TO INDEMNIFY AND HOLD HARMLESS THE AEA AND THE AEA DO-IT-YOURSELF (DIY) CLUB, AND THEIR OFFICERS, MEMBERS, ACTIVITY LEADERS, AND VOLUNTEERS FROM AND AGAINST ANY AND ALL LIABILITY, CLAIMS, DEMANDS, OR CAUSES OF ACTION WHICH ARISE OUT OF OR ARE IN ANY WAY CONNECTED WITH MY PARTICIPATION IN AEA DO-IT-YOURSELF (DIY) CLUB AND ITS ACTIVITIES OR MY USE OF THE CLUB TOOLS. 4. Should the AEA or AEA Do-it-Yourself (DIY) Club or anyone acting on their behalf, be required to incur attorneys' fees and costs to enforce this Waiver and Release of Liability Agreement, I agree to indemnify and hold them harmless for all such fees and costs.

I agree that this Waiver and Release of Liability Agreement is governed by the laws of the State of California applicable to agreements made and to be performed wholly within such jurisdiction, and I further agree that this Waiver and Release of Liability Agreement is intended to be as broad and inclusive as is permitted by the laws of the State of California.
